## AUDITING SERVICES

Evaluation & Management and Physical & Occupational Therapy Services Audits - **\$30.00** per encounter.

- If minor procedures are included as part of the E/M encounter, add **\$5.00** per procedure.
- If Labs or Diagnostics are included as part of the E/M encounter, add **\$3.00** per Lab or Diagnostic.

Office-based procedures performed with no E/M - **\$30.00** per encounter

Surgery and Procedure Audits to include most specialties including but not limited to General Surgery, MOHS, Anesthesia, ENT, Orthopedic, Cardiology, Urology, Ophthalmology, Gastroenterology - **\$40.00** per surgery regardless of the number of lines (procedures)

Surgery Audits to include Interventional Surgery (Radiology, Cardiology & Vascular), Spine & Brain Surgery - **\$55.00** per surgery regardless of the number of lines (procedures)

Risk Adjustment and Hierarchical Condition Category (HCC) Review - **\$30.00** per encounter

Medical Necessity Review by Physician - **\$60.00** per encounter

## CODING SERVICES

Evaluation and Management Encounter - **\$12.00** per encounter

- If minor procedures are included as part of the E/M encounter, add **\$3.00** per procedure.
- If Labs or Diagnostics are included as part of the E/M encounter, add **\$3.00** per Lab or Diagnostic.
- If Behavioral Health Services are included as part of the E/M encounter, add **\$3.00** per encounter.

Behavioral Health Services other than E&M Encounter - **\$12.00** per encounter

Durable Medical Equipment - **\$3.00** per encounter

Office-based procedures performed with no E/M - **\$12.00** per encounter

Surgery and Procedural Coding to include most specialties including, but not limited to General Surgery, MOHS, Anesthesia, ENT, Orthopedic, Cardiology, Urology, Ophthalmology, Gastroenterology - **\$20.00** per surgery regardless number of lines (procedures)

Surgery Coding to include Interventional Surgery (Radiology, Cardiology & Vascular), Trauma, Transplant, and/or Spine & Brain Surgery - **\$30.00** per surgery regardless of the number of lines (procedures)

## DIAGNOSIS-RELATED GROUP (DRG)

### Extensive Audit

- DRG 1-3 days per stay
  - 1 - 250 charts: **\$130.00** per chart
  - 250 - 500 charts: **\$117.00** per chart
  - 500 or more charts: **\$111.00** per chart
- DRG 4-10 days per day
  - 1 - 250 charts: **\$150.00** per chart
  - 250 - 500 charts: **\$137.00** per chart
  - 500 or more charts: **\$130.00** per chart
- DRG 11 days or more
  - 1 - 250 charts: **\$163.00** per chart

## EDUCATION SERVICES
