To Whom it May Concern:



institutional providers, such as physician practices, chiropractic practices and small medical clinics. I personally developed the curriculum used in the course and have continued to update the information and training since the first established in 2011. The curriculum is now updated with the assistance of Paul Weidenfeld, another former federal prosecutor.

In addition to the above, Sean has achieved certification in number of additional health care specialty areas.

Please understand, I do not make this recommendation lightly. As background, our law firm includes a number of former federal and state prosecutors and senior-level attorneys with decades of experience working with corporate America.
